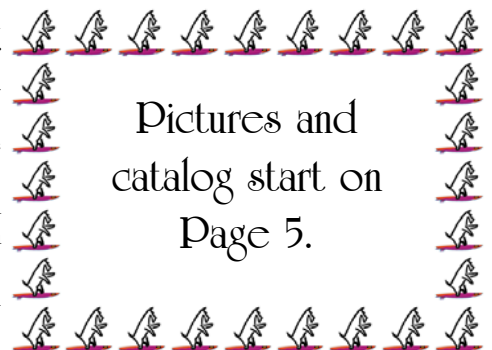

STCA NEWS**SCOTTISH TERRIER
STANDARD REVIEW**

The STCA is conducting a review of the Scottish Terrier standard. The proposed changes are currently being presented to the STCA Membership for review and comment. The proposed changes will be presented at STCA meetings, in the Bagpiper, on the STCA Website, etc. Comments are being collected from the membership. If the STCA Board approves the proposal, it will be sent to the AKC for review of clarity in wording and structure.

After a comment and review period, the final proposed standard is presented to the AKC Board of Directors. Proposed Revisions will then be printed in the AKC Gazette, now on the internet, for comments, for 60 days. It is scheduled for August 2012 publication. After the 60 days at the AKC meeting of their Board, they will either approve or deny any further steps. If they deny the proposed revisions, then that is the end of the process.

If they approve, the STCA can go forward to the next step which is a ballot of the STCA members. (this step is provided for in the STCA By-Laws, see below) STCA Membership will be mailed a ballot for a formal vote. The proposed changes are not official until the STCA membership casts their ballots for the proposal according to the STCA Constitution and By-laws. If the proposed change passes the STCA membership vote, it must have been approved by the AKC Board of Directors.

**California SB969 -
Certification for Pet
Groomers**

The Legislature is considering creating a voluntary certification program for pet groomers. Groomers would have to complete about 900 hours of training and pay an as-yet unspecified fee to be certified by the state — a designation that amounts to a Good Housekeeping Seal of Approval.

VOLUNTARY RECALL**Nature's Variety Prairie
Beef Meal & Barley

(July 12, 2012)

Nature's Variety has initiated a voluntary recall of its Prairie Beef Meal & Barley Medley Kibble for Dogs due to an off-odor smell that may develop over time. This product is not contaminated in any way, but some products are not remaining fresh for the shelf life of the product.

AKC LEGISLATION ALERT**USDA REGULATION
CHANGE ON RETAIL
PET STORES TO AFFECT
SMALL BREEDERS**

The US Department of Agriculture (USDA)/Animal Plant Health and Inspection Service (APHIS) announced today that the comment period on the proposed regulations regarding “Retail Pet Stores and Licensing Exemptions” has been extended until August 15, 2012. We encourage any concerned dog owners who have not yet signed the AKC petition and/or submitted comments about this problematic proposal to take advantage of this extra time to do so.

Background: This important proposal would require all who own more than four “breeding females” and sell even one animal “sight unseen” to be regulated as a commercial breeder and be subject to federal commercial breeder licensing, regulation and inspections. The term “breeding female” is not defined, so it is unclear how USDA or even breeders themselves would determine who falls under these regulations. The term also includes multiple species (including cats, dogs, and other small mammals).

The AKC believes that the USDA’s “one size fits all” regulations are not in the best interest of all dogs, responsible breeders, or puppy buyers. It is unreasonable and virtually impossible for many small hobby breeders to comply with the strict kennel engineering standards that were designed for large commercial operations.

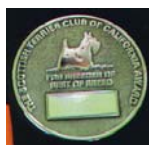

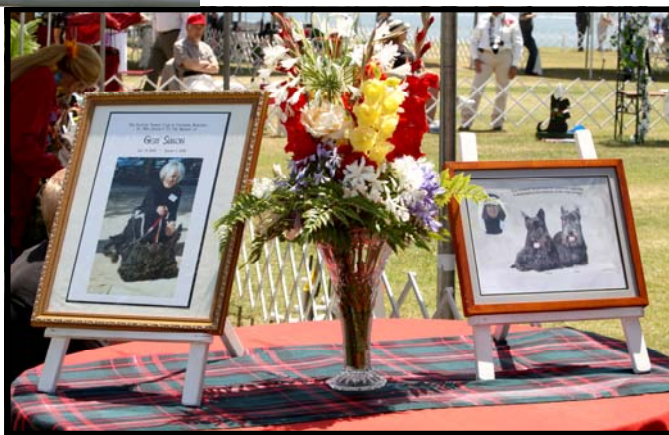

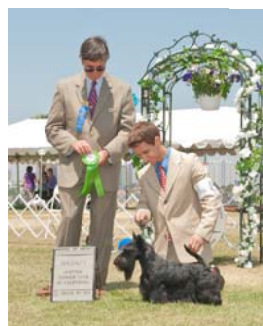

well mannered and just about 100% house trained after the Changs' diligent and devoted work with him. His new mom, a long-time Scottie owner, says "he gives his new Scottie sister, Pearl, a real run for her money, not to mention my cat. I've watched the two of them gang up on her, which may be good since my cat is fat and could use the exercise." Sparky's mom ended her email, saying "Today is my birthday and I wanted to let you and the Changs know that I couldn't have had a better birthday present than to have Sparky in my family. He is such a joy."

We bailed four year old Dory from the Agoura shelter, only to discover during her vet exam that she had two huge bladder stones. Our



vet did the surgery and after five weeks of recovery here, she was adopted to a great couple in Escondido. Her new brother is Winston, a Wire Haired Fox Terrier, and they hit it off from the get-go. Normally, we'd refer them to the San Francisco Bay Scottie Club's rescue program, but we'd just had a call from a great home wanting to adopt in the Sacramento delta area the week before. I called this retired couple to ask if the NorCal rescue had found them a Scottie yet and they said they hadn't heard back from them yet. Long story short, Tilly was in her wonderful new home the next day,

after we contacted this couple's vet and groomer for references. Tilly's new family belongs to an RV camping club and Tilly



will become a well-traveled dog. "She loves to jump in the car anytime we are running errands around town and we can't wait to see how she takes to our monthly travels. Just about everyone in our RV club has a dog or two," Tilly's new mom wrote recently, "and we love that she Ahroos!"

When I called Paul to see if he could "eyeball" a possible Scottie at the very crowded high-kill San Fernando East Valley shelter near his home, he was there the very next morning. Paul called me and said she was not a purebred Scottie but while there he decided to offer help six hours a month grooming shaggy, matted dogs to make them more adoptable. No doubt the dogs Paul grooms will find new forever homes, which they otherwise might not have.

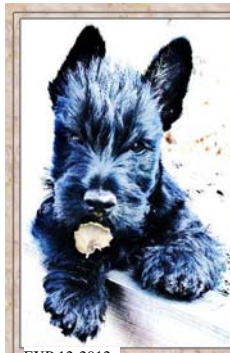
